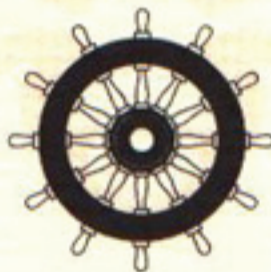

Product description

“RAI - ATF - 25”

consisting of 600 mm wide panels, made from 23 mm mineral wool of type “NOBASIL SH” of density 150 kg/m³, covered on both sides with 0.7 mm galvanised steel sheets bonded to the mineral wool with an adhesive of type “Mitopur 402 SU”. The panel joints are made of steel profiles and the joints of the panels are reinforced by replacing the mineral wool in a distance of 50 mm on both sides of the joint with a mineral wool of same type with density of 200 kg/m³. Total bulkhead panel thickness 25 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-0.

The insulation (NOBASIL SH) and any surface material used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation, use and maintenance.

Mark of conformity

The manufacturer is allowed to affix the Mark of Conformity  according to Article 11 in the Council Directive 96/98/EC on Marine Equipment and issue a Declaration of Conformity, only when the module D or E or F of Annex B in the same directive is fully complied with.

- Module D: The quality system for production and testing shall be approved by the Notified Body.
- Module E: The quality system for inspection and testing shall be approved by the Notified Body.
- Module F: Compliance of the products to type as described in this EC Type-Examination Certificate must be verified by the Notified Body who also shall issue a Certificate of Conformity.
